CONCURRENT RESOLUTION

Setting forth the congressional budget for the United States Government for the fiscal years 1981, 1982, and 1983 and revising the congressional budget for the United States Government for the fiscal year 1980.

1 *Resolved by the House of Representatives (the Senate*
2 *concurring)*, That the Congress hereby determines and de-
3 clares, pursuant to section 301(a) of the Congressional
4 Budget Act of 1974, that for the fiscal year beginning on
5 October 1, 1980—

6 (1) the recommended level of Federal revenues is
7 \$613,800,000,000, and the amount by which the ag-

1 aggregate level of Federal revenues should be decreased
2 is \$10,300,000,000 and the amount by which the ag-
3 gregate level of Federal revenues should be increased
4 is \$4,300,000,000;

5 (2) the appropriate level of total budget authority
6 is \$694,600,000,000;

7 (3) the appropriate level of total budget outlays is
8 \$611,800,000,000;

9 (4) the amount of the surplus in the budget which
10 is appropriate in the light of economic conditions and
11 all other relevant factors is \$2,000,000,000;

12 (5) the appropriate level of the public debt is
13 \$926,800,000,000 and the amount by which the statu-
14 tory limit on such debt should accordingly be increased
15 is \$30,100,000,000; and

16 (6) the appropriate level of total gross obligations
17 for the principal amount of direct loans is
18 \$60,600,000,000 and the appropriate level of total
19 commitments to guarantee loan principal is
20 \$79,600,000,000.

21 SEC. 2. Based on allocations of the appropriate level of
22 total new budget authority and of total budget outlays as set
23 forth in paragraphs (2) and (3) of the first section of this
24 resolution, the Congress hereby determines and declares pur-
25 suant to section 301(a)(2) of the Congressional Budget Act of

1 1974 that for the fiscal year beginning on October 1, 1980,
2 the appropriate level of new budget outlays authority and the
3 estimated budget outlays for each major functional category

18 Budget Act:

22 year 1981 in reported or enacted laws, bills, and reso-
23 lutions that reduce spending by \$520,000,000 in
24 budget authority and \$520,000,000 in outlays and are
25 instructed to report on or before June 15, 1980, such

1 recommendations to effectuate reductions in corre-
2 sponding new budget authority for fiscal year 1981,
3 budget authority initially provided for prior fiscal years,
4 and new or existing spending authority for programs
5 within the jurisdiction of those committees;

6 (2) the Senate Committee on Agriculture, Nutri-
7 tion, and Forestry shall reduce spending for fiscal year
8 1981 in enacted laws, bills, and resolutions by
9 \$533,000,000 in budget authority, and \$507,000,000
10 in outlays and is instructed to report on or before June
11 15, 1980, its recommendations for changes in new
12 budget authority for fiscal year 1981, budget authority
13 initially provided for prior fiscal years, and new or ex-
14 isting spending authority contained in enacted laws,
15 bills, and resolutions within the jurisdiction of this com-
16 mittee sufficient to accomplish the reduction required

16 (f)(1) the House Committee on Public Works and
17 Transportation and the Senate Committee on Environ-
18 ment and Public Works shall recommend program re-
19 ductions for fiscal year 1981 in enacted laws, bills, and
20 resolutions that reduce spending by \$400,000,000 in
21 outlays and are instructed to report on or before June
22 15, 1980, such recommendations to effectuate reduc-
23 tions in corresponding outlays for programs within the
24 jurisdiction of those committees;

1 (2) the House Committee on Public Works and
2 Transportation shall reduce spending for fiscal year
3 1981 in enacted laws, bills, and resolutions by
4 \$150,000,000 in budget authority and \$150,000,000
5 in outlays and is instructed to report on or before June
6 15, 1980, its recommendations for changes in new
7 budget authority for fiscal year 1981, budget authority
8 initially provided for prior fiscal years, and new or ex-
9 isting spending authority contained in reported or en-
10 acted laws, bills, and resolutions within the jurisdiction
11 of this committee sufficient to accomplish the reduction

24 enacted laws, bills, and resolutions within the jurisdic-
25 tions of those committees, or for programs within the

1 jurisdictions of those committees, sufficient to accom-
2 plish the reduction required by this subsection;

3 (h) the House Committee on Ways and Means
4 shall reduce spending for fiscal year 1981 in reported
5 or enacted laws, bills, and resolutions by \$717,000,000
6 in budget authority and \$1,869,000,000 in outlays,
7 and is instructed to report on or before June 15, 1980,

3 (j) the Senate Committee on Finance shall reduce
4 spending for fiscal year 1981 in enacted laws, bills,
5 and resolutions by \$917,000,000 in budget authority

7 report on or before June 15, 1980, its recommenda-
8 tions for changes in new budget authority for fiscal
9 year 1981, budget authority initially provided for prior
10 fiscal years, and new or existing spending authority
11 contained in enacted laws, bills, and resolutions within
12 the jurisdiction of this committee sufficient to accom-

14 (k) the Senate Committee on Labor and Human
15 Resources shall reduce spending for fiscal year 1981 in

6 recommendations for changes in revenues for fiscal
7 year 1981 contained in reported or enacted laws, bills,

11 SEC. 4. In accordance with section 301(b)(1) of the
12 Budget Act, no bill or resolution providing new budget au-
13 thority for fiscal year 1981 or providing new or existing
14 spending authority described in section 401(c)(2)(C) of the
15 Budget Act in excess of the allocation of the appropriate
16 levels of total budget outlays and total new budget authority
17 submitted pursuant to section 302(b) of the Budget Act, shall
18 be enrolled until Congress has completed action on the
19 second budget resolution for that fiscal year as required to be
20 reported under section 310 of the Budget Act; and, if a rec-
21 onciliation bill or reconciliation resolution, or both, are re-
22 quired to be reported under section 310(c), until Congress
23 has completed action on that bill or resolution, or both.
